RULES

1. Each melody may have only one author. A submission credited to more than one child will not be accepted.
2. Submit the original melody on CD or in music notation together with the completed 2 page application.
3. Children may submit more than one melody up to a maximum of three, but each submission must have a separate, fully completed and signed application.
4. Parents or teachers may submit more than one entry on a single CD, but each melody must be preceded by the name, age, city of residence of the child and title of the melody. Please make sure the child or children's names are on the CD to avoid confusion.
5. If a child's ensemble piece is selected for the *Hey, Mozart! New Mexico* project, he or she may have additional musicians perform with him or her at the 2011 concert, provided that the other parts are the child's independent harmony parts (for example, piano duet, trumpet trio, string quartet). No doubling of the composer's part will be allowed on the recording or at the concert.
6. If his/her melody is selected, the child and his/her family are encouraged to attend the concert in Albuquerque in November 2011 at which the child will perform. Mileage expenses will be reimbursed for children living more than 60 miles distant from Albuquerque.

Hey, Mozart! New Mexico Child Composer Project

This Agreement ("Agreement") is between _____ (name of parent or guardian) ("Parent") and *Hey, Mozart! New Mexico*, a New Mexico non-profit corporation, ("HMNM").

Parent understands that the child named below who is a minor ("Child") has authored a composition that may be included in *Hey, Mozart! New Mexico's* Child Composer Project, an annual community outreach music program that fosters children's natural talent for inventing melodies. If selected for inclusion, Minor's compositions or melodies ("Melody") will be arranged by a musician, recorded by an ensemble, and the recordings of various children's arranged melodies will be compiled on a DVD or CD. The arrangement may also be shared with ensembles throughout the state and elsewhere to promote the project.

In consideration of the above and subject to the terms and conditions, the parties agree as follows:

Parent hereby grants to HMNM a royalty-free, non-exclusive, worldwide license to the Melody with the right to prepare derivative works and to use, reproduce, sell, sublicense, and perform the Melody including but not limited to arranging, orchestrating, recording, reproducing, re-recording, duplicating, releasing, selling, distributing, manufacturing, broadcasting, and including but not limited to performance rights in all media and in all advertising. Parent understands that there may be multiple arrangements, orchestrations, performances, recordings, and reproductions of the Melody.

Parent consents in behalf of herself/himself and/or Minor for all purposes, to the reproduction, and/or use of Minor's voice, biography and/or images by HMNM and by any designee, licensee or assignee of HMNM in all forms and media including advertising.

Parent hereby warrants and represents that he/she has ownership and control of the rights to the Melody granted herein, and has authority to sign this Agreement on behalf of the Minor.

Parent agrees that HMNM may copyright any derivative work of the Melody in the name of HMNM. Parent may apply for copyright of the original Melody in Minor's name. Copyright of the original Melody means that no individual or organization, other than HMNM is hereby granted permission to use the original Melody without Parent's or Minor's (when no longer a minor) permission.

The term of this Agreement is from the date of signature below until expiration of any copyrights of the Melody and any derivative works thereto.
